6 I, Lxxxx Kxxxxx, being first duly sworn, depose and say under oath that:

- 8 1. I have witnessed the following. I have personal knowledge of and am competent to  
9 testify to the matters stated herein.

11 2. On or about Sunday, September 21, 2014, around at 7:30 AM, I noticed a Golden  
12 Retriever, which I later learned belongs to a neighbor, one Rick Jackson, defecating  
13 on the lawn of my home at 78 Fir Street, Shady Cove, Oregon.
  - 14  
15 3. I attempted to shoo the dog away, to no avail. Knowing that the dog did not belong  
16 to my immediate neighbors, I crossed Fir Street to our neighbor's house at 10 Fir  
17 Street to see if the dog was theirs.

20 4. I knocked on the door and a woman whom I later learned is named Cynthia,  
21 answered the door. I asked if the dog was hers. She bolted out of the door and  
22 began assaulting me verbally in a hysterical fashion, calling me a "crazy bitch" and  
23 other uncomplimentary names. I was incredulous. Realizing that this woman was not  
24 "right in the head," I returned home.

1 5. I was outside about half an hour later, and I noticed Mr. Jackson walking up my  
2 driveway carrying a stick in his hand in a threatening manner. The stick was about  
3 five feet long. Feeling threatened, I asked him to leave. He continued his advance  
4 and began shouting epithets, calling me a “crazy bitch” and other slurs. I told him to  
5 go home and that he was trespassing and retreated into the house. Once inside my  
6 home, I looked out the window and noticed that he had left.

9 6. Two days later, on or about Tuesday, September 30, 2014, at about 10:30 AM, I was  
10 returning home from a visit with my immediate neighbors, Mxxxxxx and Exxx  
11 Txxxxxxx, at their home at xx Pine Street, and noticed an Animal Control vehicle  
12 parked at xx Pine Street. Walking towards that vehicle, I noticed an Animal Control  
13 Officer who later identified himself as “Officer Mike,” outside the deck of my home,  
14 attempting to gain control of a Golden Retriever that had found its way to my deck.  
15 This was the same Golden Retriever that had made its mess on my lawn two days  
16 earlier.

18 7. A short time later, Officer Mike returned to my home, asking Cxxxx Pxxxxxxx with  
19 whom I live, if he would like to make a formal complaint. The officer confirmed that  
20 the dog did indeed belong to my neighbors at 10 Fir Street.

23 8. Almost one week later, on or about on October 6, 2014, at about 7:15 AM, I noticed  
24 the same Golden Retriever belonging to Mr. Jackson and Cynthia, again relieving
